


सम्पादकीय—



Welcome Speech by CHAIRMAN Silver Jubilee Celebration Committee

Hon'ble Sri Chittatosh Mukherjee Chief Justice, Calcutta High Court Hon'ble Sri Thakurdas Sugla Judge, Bombay High Court

Ladies, Gentlemen and Friends,

AVANTIKA was established way back in the year 1962. Since then about quarter of a century has passed and the year 1987 is the Silver Jubilee year of the Organisation. The period of 25 years in the life of an organisation is not a very long one but nevertheless it is a land-mark in the history of any organisation.

Avantikans are proud that today's function is being inaugurated by a person of no less eminence than the Honourable Chief Justice of Calcutta High Court, Sri Chittatosh Mookherjee. Honourable Shri Mookherjee is a well known personality of this great city. He comes from the illustrious family of great legal illuminaries. His grand-father Sir Asutosh Mookherjee and father Shri Rama Prasad Mookherjee had both acted as Chief Justice of the Hon'ble Calcutta High Court and keeping the heritage, our Chief Guest Shri Chittatosh Mookherjee is also holding the high office of Chief Justice of the same High Court. Such instances are rare to be found in history. Hon'ble Sri Mookherjee had a success ful and distinguished practice at the Bar of the Calcutta High Court for about sixteen years when he was elevated to the Bench of Calcutta High Court from 2nd April, 1969 and thereafter appointed its Chief Justice on 1st November, 1986

Earlier also, Avantikans had the honour of receiving Chief Justice Shri D. N. Sinha as their Chief Guest and keeping up the tradition, I feel greatly honoured to offer, on my own behalf and on behalf of the whole Avantika Pariwar, a very warm welcome to honourable Chief Justice Shri Chittatosh Mookherjee.

Hon'ble Shri Thakurdas Sugla does not need any introduction to the members of Avantika. Shri Sugla had been one of the oldest members of Avantika. When he was in calcutta he had even served as President of our organisation during the year 1965-66. He continued to be an active member of Avantika till he joined the Income Tax Appellate Tribunal as a member thereof in 1967. Even thereafter, he did not loose his interest in Avantika and its members and whenever he had occasions to visit Calcutta he used to meet old Avantikans and enquire from them about the current activities of the organisation. As all of you are aware, he later on become the President of Income Tax Appellate Tribunal in the year 1980 and continued to function in that capacity till middle of 1986 when he was elevated to the Bench of Bombay High Court, an honour which he greatly deserved. Avantika and its members are proud that one of their members could rise to such an important position. It is, therefore, in the fitness of things that Hon'ble Justice T. D. Sugla is present on the occasion of Silver Jubilee Celebrations of Avantika and is presiding over the first function. I offer him a warm welcome not only on behalf of myself but also on behalf of all Avantikans.



ADDRESS BY PRESIDENT

Twenty five years ago Calcutta was the economic and financial capital of India, the home of noted, talented and high calibre professionals. The contribution of these individuals in all important sphers of life was immense. Not only were they recognised in India but some of them also became international professional figures. But there was a vacuum of common platform for discussion on Indian culture, literature etc.

With a view to bridge this gap as well as to create a consciousness among them about cultural and literary beritage of India "Avantika" was established in 1962 by a few friends—Lawyers, Chartered Accountants etc. who in their working life, were handling complex problems of law and accountancy while in their hearts they tearned for literature, culture and learning. The main object of "Avantika" is to promote cultural and mental development of members by organising intellectual, literary, cultural and social functions, at the same time remaining aloof from political and religious groups. They also invite for deliberation dignitaries from the field of law, literature and culture because according to Avantikans, these three heritages go a long way in weaving the fabric of a strong society which is their own. They had in the past, privilege of receiving leading personalities of different fields as their honoured guests.

Over the years "Avantika" like any other society, had its ups and downs. During some years, it has been able to organise many literary as well as cultural events which were enjoyed and appreciated by members and outsiders alike. In other years its performance has been less outstanding. Avantika has demonstrated a tenacity and will to servive and flourish despite many odds in its path as demonstrated in this Hindi poem:


इस तरह तय हमने की मंजिले। गिर पड़े, गिर कर उठे, उठ कर चले।
